As per Jason Tait at the Office of Campaign and Political Finance, I am attaching this memo to confirm the notes and copy of the check drawn to close out Michael's campaign account in June.

Michael forgave both his loan and the out-of-pocket expenses on the Dissolution Report we filed on June 11, 2022.
